

Terms & Conditions Saudi Gateway Club – Online Membership

Welcome to Saudi Gateway Club (“the Club”, “we”, “us”, or “our”). By accessing or using our services, you agree to comply with and be bound by these Terms & Conditions (“T&Cs”). Please read them carefully.

1. Introduction

- Saudi Gateway Club is registered in Bahrain under Cr no. 123725-01.
- These T&Cs govern your use of the Club’s online platform, services, and content.
- Accessing or subscribing to our services constitutes acceptance of these T&Cs.

2. Eligibility

- Membership is available to individuals and businesses who are legally capable of entering binding contracts.
- Users must provide accurate, complete, and up-to-date registration information.

3. Membership and Services

The Club offers members access to the following benefits and deliverables:

- **Resource Library:** permanent on-demand access to a curated collection of practical resources including a vetted provider directory, guides, checklists, and the full archive of member content. Updated quarterly.



The Club reserves the right to adjust the format, frequency, or content of deliverables with reasonable prior notice to members.

- Membership is non-transferable unless explicitly approved in writing by the Club.

4. Subscription and Payment

- Accepted Currencies: EUR, USD, GBP, and other supported currencies.
- Exchange rates are applied at the time of payment.
- Billing:
 - Payments are due upon subscription activation.
 - Recurring subscriptions (if any) are automatically charged per plan.
 - Subscription renewal occurs automatically unless cancelled by mail (admin@saudigatewayclub.com) before the next billing cycle.
- Payment Methods: Credit card, bank transfer, and approved online payment gateways.
- Failed Payments: Access may be suspended until payment is successfully processed.
- International Taxes: Users are responsible for any taxes (VAT, GST, etc.) applicable in their jurisdiction.

 2. If unresolved, arbitration under ICC rules or Bahrain courts (unless otherwise mutually agreed).
- Arbitration proceedings will be conducted in English unless otherwise agreed.
